After the 2022 IFT Convention, the IFT continued to implement strategic plans supporting the organizational priorities of public education, economic fairness, equity and inclusion, and member and community engagement. With the implementation of these initiatives, the IFT consistently reviewed the allocation and expenditure of resources. The IFT administrative staff were charged with determining a reallocation of resources over the last three years to ensure adequate support for the strategic plan as fiscal pressures increased.

Delegates at the 2022 convention approved dues increases expressly to help organize more members, with a strong emphasis on organizing more support staff units (PSRPs). In all departments, staffing was reviewed, and staffing ratios modified to better serve the locals and members. The IFT has continued to expand organizing efforts and coordinated campaigns in partnership with the AFT with its existing professional organizing and field staff and the addition of a temporary organizer. We are proud to report that these efforts have resulted in the organization of 30 new IFT units, and over 8,000 new bargaining unit members, including 1,100 new PSRPs in 20 newly organized councils! Targeted internal organizing campaigns have increased membership of existing locals throughout the state as well. We were able to achieve this growth without an increase in the total number of employees.

The proposed 2026-2028 budget approved by the IFT Executive Board provides for funding the continuation of service with emphasis on member engagement and action with measured, reasonable, and sustainable dues increases. As we look ahead, we plan on increasing our organizing efforts—particularly toward the tens of thousands of paraprofessionals in Illinois who still do not have a union, civil service employees, employees at Regional Offices of Education and Intermediate Service Centers, as well as other unrepresented educational workers. We will continue supporting our local unions' efforts to bargain best-in-class collective bargaining agreements that ensure real gains for our members and communities. We also know we will need more resources to address the teacher and staff shortages that are plaguing our state. And we must address the retirement inequity that exists for our union siblings in the Tier II pension system. We believe the proposed budgets will allow us not only to sustain ourselves as a union, but to achieve our vision of "members fighting powerfully for a strong union and the future we all deserve." While the ending figures in 2028 show a deficit of over \$376,000, that owes mostly to the one-time convention costs incurred in '28 and we do not foresee a structural deficit. The proposed budget projections assume a full-time equivalent (FTE) membership of 74,262.

The Executive Board reviewed the budget projections for calendar years 2026-2028 on July 16, 2025, and recommended approval of the per capita rates to present to the 2025 IFT Convention for approval by delegates. The Executive Board strongly encourages the delegate body to adopt the budget and per capita amendments as proposed.

Over the last three years, the committee has met more consistently and made significant strides in advancing our digital communications strategy. We've expanded our reach with a stronger, more intentional social media presence that's driving higher engagement and attracting more followers. Initiatives like *Member Mondays* spotlight the powerful stories of our members, while our *Friday Weekly Recap* keeps followers informed on key legislative issues and encourages them to take action. We've also increased interaction by posting more shortform video content and actively responding to comments and messages building a more connected and informed online community.

In addition to our digital growth, we've continued to support our locals with their communications needs. Over the past three years, we've provided strategic communications support during several strikes, including media outreach, spokesperson training, and drafting a wide range of communications materials to help locals amplify their message and advocate effectively for their members.

Specific accomplishments and projects of the committee since the 2022 convention include:

#### **SOCIAL MEDIA GROWTH**

- Since the 2022 IFT convention, the communications department has become more active on social media platforms Facebook, Bluesky and Instagram.
- Due to the engagement, we've had considerable growth on our social media platforms.

o Facebook: 11% growth

o X: 8% growth

o Instagram: 39% growth

o Bluesky (joined in January 2025): 728% growth

#### **MAIN CAMPAIGNS**

Since our last convention in 2022, we've taken on several major campaigns, including **Fix Tier 2, the 2024 presidential election, the Chicago mayoral race, and the fight against the Invest in Kids voucher program**. Digital media played a critical role in amplifying our message, helping us cut through the noise and reach members and allies. We designed compelling graphics to drive engagement on social media, created shareable content to break down complex issues, and helped shape the public narrative. Just as importantly, we elevated our members' voices by sharing their stories, testimonials, and perspectives to humanize the issues and build authentic, grassroots momentum.

#### **MEMBER MONDAYS**

Every Monday, through our *Member Monday* social media series, we shine a spotlight on the powerful stories of our members, educators, support staff, and public employees, who go above and beyond every day. In an era where organizations like the Illinois Policy Institute (IPI) work overtime to discredit unions and public education, *Member Monday* is our way of cutting through the noise and countering misinformation with truth, heart, and pride. By consistently elevating our members' voices, we're not just telling our story but we're reclaiming the narrative.

#### NOTABLE LOCAL SUPPORT

IFT's Department of Communications continues to provide comprehensive support to locals, councils, and chapters. This includes strategic communications planning, media outreach and placement, assistance with social media and digital content, crisis communications, trainings, and responsive day-to-day support. We are also incorporating digital communications as a powerful tool to tell our own stories by highlighting the real experiences of our members, countering misinformation, and ensuring that our voices are heard loud and clear across Illinois.

The department of communications has provided strategic communications assistance to locals including some of the major strikes including:

- University Professionals of Illinois Local 4100 strikes In 2023, three universities across Illinois went on strike demanding a fair contract.
- **Decatur Federation of Teaching Assistants, Local 4324** provided assistance during their bargaining contract negotiations.
- Joppa Maple Grove Federation of Teachers Local 6598, successful annexation campaign
- AICE provided strategic communications support during their bargaining negotiations in 2024
- CFAC In 2023 and 2024, the communications department provided strategic communications during the longest adjunct strike in Illinois' history.
- Supported four school board victories via mailers

#### **UNION LINK**

To reduce costs and dedicate more time to digital communications, we have scaled back *Union Link* to two issues per year. Our printed newsletter will now be digital and will continue to prioritize member engagement by offering timely, and useful information, including special election editions.

#### COMMUNICATIONS DEPARTMENT

The Communications Committee would like to recognize the staff in the Department of Communications, who work tirelessly to deliver the union's message through both digital and traditional platforms. - Pushed for more funding for CTE statewide
- Explored dual courses for CTE classes
- Discussed challenges around funding disbursement with Perkins funds
- Arranged meetings between CTE CC members, local IFT leaders and ISBE staff to discuss, understand, and offer input to proposed CTE-related Administrative Rules
- Committee identified goals for Illinois and IFT work moving forward

#### Goals Coming out of Committee:

- Funding "Cheat Sheet" to help understand funding flows from Federal and State dollars
- Creating a promotional video highlighting CTE in different areas of state
- Creating communications for distribution to encourage enrollment in CTE and various pathways to careers
- Develop communications around non-traditional licensure for CTE instructors
- Working with ISBE to have CTE courses receive core coursework credit

#### Committee invited Guest Speakers:

The last two reports from the Higher Education Constituency Council have begun with the sentence: "Higher Education in Illinois has faced unprecedented challenges over the past three years." Unfortunately, these challenges continue to grow, but our resolve to fight back is even stronger.

Over the last three years, the Constituency Council has met in person during larger IFT meetings, as well as via Zoom (sometimes monthly) to address ongoing challenges. Internally, we have focused on growing the number of active Constituency Council members, with special attention to central and downstate community college Locals. We are pleased to report that more members are now participating, sharing ideas, and engaging in planning and actions.

Collectively, we have worked to stop legislation that would have lowered the quality of dual credit courses. In the last legislative session, new dual credit legislation passed that added additional quality protections for students and the faculty teaching these courses. We continue to demand that dual credit courses provide students with a solid higher education experience: an experience that sets them up for success when they enter a higher education institution. Further, we continue to maintain that teaching faculty retain their academic freedom in dual credit programs to ensure rigorous and appropriate, curricula that match the courses taught at community colleges and universities. This also includes securing representation on a key state board that will monitor the quality of dual credit courses.

We also worked together to push the legislature to establish a new task force that explores the vital role of faculty in our community college and university libraries. Faculty librarians have faced serious threats to their job security and their roles as educators. In fact, Western Illinois University laid off all its faculty librarians this past spring. The new task force will produce a report that illustrates and highlights the essential role faculty librarians play in student success, as well as in the success and growth of their communities.

After passing legislation in 2019 that allowed graduate research assistants to organize, we supported the UIC GEO and UIUC GEO in two major organizing victories at both the University of Illinois Chicago and the University of Illinois Urbana-Champaign. These two large groups represent hard-working research assistants who are often underpaid, overworked, offered few benefits, and given little job security all while being taken for granted. They are now engaged in contract campaigns to improve the working conditions of thousands of graduate research assistants.

In addition to the new bargaining units at UIC and UIUC, we successfully organized the Illinois State University tenure/tenure-track faculty and the University of Illinois Springfield contingent faculty. This past spring, both units of the University Professionals of Illinois Local 4100 reached groundbreaking and life-changing contracts for their members. These first-time contracts will transform the culture on both campuses. Both contract campaigns succeeded because of the strength of their memberships and the support of IFT Higher Education Constituency Council members statewide who stood with them in their fight.

Together, we continue to push back against attacks on higher education. Many of our members have joined rallies and spoken at press conferences opposing the federal cuts to vital research and creative grants. We continue to meet with AFT to better understand the challenges we face as a result of recent federal budget bills that undermine public education at all levels. In addition, we are pressing our colleges and universities to protect our undocumented students, as well as our international faculty, staff, and students. This includes direct actions on our campuses and providing assistance to help students, faculty, and staff access the resources and support they need to navigate these challenges. We continue to push back against attacks on academic freedom and free speech on our campuses. Our students, faculty and staff deserve a right to express their opinions and to stand up for their beliefs.

As a Council, we recognize that the challenges ahead are significant. We are working to coordinate bargaining demands where appropriate and continue to advocate for full funding for our community colleges and public universities, which includes demanding the passage of the Equity Funding Bill for public universities, as well as a similar bill for our community colleges. While the student debt crisis in this country must be addressed, we know that the first step is to fully fund our public higher education institutions so that all students can pursue their futures without the fear of lifelong debt.

The Locals/Organizing Committee is designed to create, improve policies, and make recommendations to the IFT Executive Board on matters related to internal and external organizing projects, and the overall welfare of locals within the IFT.

At our last convention in 2022, this committee and the delegates set out a big goal: to go after the thousands of unorganized PSRPs across the state, and to finally take on the fight to organize Research Assistants at our public universities. We can report back now that we were successful and victorious. In the past three years we organized thousands of PSRPs into new councils and locals, giving school support staff a real union voice. And after years of talking about it, we finally broke through in higher education, winning Research Assistants at UIC and moving forward with a massive RA unit at UIUC.

These victories gave voice to thousands of workers who deserved dignity at work, and they show what is possible when we commit to organizing at scale. At the same time, we had setbacks and some tough losses, but the overall trend is clear: more workers are joining IFT and standing up for themselves on the job. The challenges are real (drops, anti-union attacks, economic strain) but the trend is clear: our union is growing, fighting, and winning.

#### 1. External Organizing

#### **Higher Education**

- University of Illinois-Chicago (UIC) Research Assistants 1,000 new members organized in 2024.
- University of Illinois-Urbana Champaign (UIUC) Research Assistants 3,800-person campaign filed in 2025, the largest higher ed unit ever for the IFT.
- Illinois State University Faculty 650 tenure-line faculty organized, a win after decades of failed attempts by IEA and IFT.
- Moraine Valley, Lake County College Tech Workers certified and building strong committees.

#### **Private Schools and Charter Schools**

- Francis Parker Assistant Teachers voluntarily recognized in 2025, a rare and important victory.
- Rogers Park Montessori about 60 teachers and assistants, certified and bargaining first contract.
- Near North Montessori a tough election lost in 2025, showing the uphill battle in private schools.



#### K-12 Support Staff and Accretions

- Gurnee District 56 (Local 504) -70 workers.
- New Lenox District 122 (Local 604) 155 workers.
- **Bloomingdale District 13** 39 workers.
- Woodland Subs (Local 504) certified in 2024.
- CTU (Local 1) nearly a thousand new members through the addition of job titles and roles.

#### **Total Membership Growth**

Since 2022, IFT has organized over 8,000 new members through 76 campaigns, with thousands more in the pipeline.

#### 2. Internal Organizing

The Janus decision still impacts us, but our numbers have stayed strong. Membership is now at the highest level since 2017, with growth across higher ed, K-12, and private schools.

- **Electronic Cards** In 2024, IFT launched electronic join cards for members. Over 1,700 people joined in just 45 days. This has been called a game changer by staff.
- **Guard, Grow, Get** A program rolled out in 2024 to guard against drops, grow internal membership, and get new organizing targets.
- **Drops** Still about 200 per year. Most are PSRPs who are closest to the margins and need more direct engagement.

#### 3. Immigrant Rights

Immigrant members of IFT have faced more challenges in the last 3 years. Visa cancellations, targeted enforcement, and family disruptions all hit our members.

IFT responded with:

- **Know Your Rights Trainings** in Chicago, Champaign/Urbana, Bloomington/Normal, Waukegan, and Peoria.
- Union Plus Immigration Services for members needing legal help.
- Direct staff interventions in cases where members were detained or needed assistance processing immigration paperwork.

This work is not a side project. It is central to our union.

#### 4. Political Engagement and Mobilization

- May Day 2025 The largest May Day in U.S. history, with IFT and CTU in central roles. Over 1,000 actions nationwide, and thousands in Chicago. Students, educators, and community marched together from Union Park to Grant Park.
- **Elections** Staff and locals were active in school board races, mayoral campaigns, and national elections. In many cases, locals ran their own programs to fight back against anti-union candidates.
- Forays into Bargaining for the Common Good Trainings and campaigns since 2023 showed how to link member demands with community demands.

#### **Purpose and Mission**

The Next Gen Constituency Council's goal is to strengthen engagement among newer and younger members of the Illinois Federation of Teachers. Over the past three years, the Council has met regularly to identify challenges, share ideas, and develop strategies to ensure that all members—regardless of experience level—feel connected to the union's mission and empowered to advocate for their rights.

#### **Key Themes and Focus Areas**

#### **Tier 2 Pension Reform**

The most consistent and urgent concern raised by members was the inequity of the Tier 2 pension system. Members emphasized that fixing Tier 2 is not just a Tier 2 issue - it's a union-wide priority that affects solidarity, recruitment, and long-term sustainability. The Council worked to educate Tier 1 members on why Tier 2 reform matters to everyone.

#### **Retiring With Dignity Resolution**

In response to pension concerns, the Council drafted and submitted a resolution titled "Retiring With Dignity" for consideration at the IFT Convention. The resolution calls for legislative and organizational action to ensure all educators can retire with financial security and respect.

#### **Recruitment and Engagement Strategies**

The Council brainstormed and piloted ideas to recruit and retain younger members, including:

- Peer-to-peer outreach and mentorship programs
- Social media campaigns highlighting union wins and member stories
- Regional meetups and listening sessions to build community
- Leadership development opportunities tailored to early-career educators/members.

#### **Impact and Next Steps**

The Council has laid a strong foundation for intergenerational solidarity within IFT. Moving forward, the group recommends:

- Continued advocacy for Tier 2 reform
- Expansion of Next Gen programming across the state
- Ongoing collaboration with other IFT constituency groups to amplify shared goals

The P-20 Educational Policy Committee met at the regularly scheduled IFT Executive Board meetings during 2023-2025. The committee members wish to thank all of the IFT staff for their valued input, assistance and support.

## POLITICAL ACTION COMMITTEE REPORT SUMMARY

The IFT Political Action Committee (PAC) balances the needs of locals with those of the statewide federation. To accomplish this, we engage in three levels of candidate evaluations: PAC regions, Statewide PAC, and IFT Executive Board. At the regional level, members are invited to attend candidate interviews and review candidate questionnaires. Regional meeting attendees make recommendations to endorse a candidate, not endorse in a contest, or defer the decision to the Statewide PAC. The Statewide PAC reviews the regional recommendations, makes adjustments as necessary, and forwards endorsement recommendations to the IFT Executive Board. The IFT Executive Board makes the final endorsement of a candidate. The Statewide PAC and Executive Board rarely overturn regional recommendations due to the priority placed on member engagement.

The presidents of all locals with members in a region are notified of the meetings in their area, all IFT members are notified by e-mail, and a full schedule of meetings is posted on the IFT website. Candidates are encouraged to attend these meetings to answer our questions and clarify questionnaire responses. Besides serving as a basis for an endorsement, the regional meetings provide an opportunity to establish and build relationships with candidates and elected officials. Participation in these sessions is critical to the success of our endorsement process and political program.

In 2024 PAC meetings were conducted for the primary and general election. IFT complied with all notifications of scheduling and cancelations required under the IFT Constitution and By-Laws. In 2024 there were 19 regional meetings in which 50 different locals and 164 members participated.

In the end, the strength of the IFT PAC process and our recommendations depends on member involvement. We encourage members to attend the regional PAC meetings in order to make this process successful. These meetings typically take place in December and January for primary elections and June and July for the general elections.

Following this report, you will find Article XI of the IFT Constitution that governs the endorsement process and lists of endorsements made since the last IFT Convention.

# ARTICLE XI ILLINOIS FEDERATION OF TEACHERS POLITICAL ACTION COMMITTEE (IFT PAC)

**Section 1.** The IFT PAC shall be composed of nineteen (19) members, eighteen (18) of whom shall represent a region approved by the IFT Executive Board. One (1) member shall represent statewide locals. The IFT Executive Board shall designate one (1) member to serve as Chair.

**Section 2.** The members, hereinafter referred to as Regional PAC Chairs, shall be appointed by the Executive Board and serve terms coterminous with the Executive Board.

#### **Section 3.** The two major activities of IFT PAC are:

#### (A) Endorsement Process

- **Step 1.** Notice of the eighteen (18) Regional IFT PAC endorsement meetings will be mailed by the IFT Springfield legislative office at the request of the Regional PAC Chair to all Presidents of locals who reside in the region.
- *Step 2.* The regional endorsement meeting will be conducted by each Regional PAC Chair with the assistance of an assigned IFT staff member to:
  - (1) inform the regional members by a legislative/political report including a review of the voting records and/or questionnaire responses of candidates prepared by the IFT Department of Political Activities.
  - (2) receive local endorsements for all regionally elected state and federal offices that are open for election including U.S. House of Representatives, Illinois appellate court justices, Illinois supreme court justices, state representatives, and state senators.
  - (3) attempt to resolve any conflicting recommendations by consensus of the locals in attendance at the regional endorsement meeting.
  - (4) make recommendations for those offices in which the locals do not make any endorsement recommendations.
  - (5) cause a report to be drafted with the assistance of the IFT Department of Political Activities listing agreed recommendations, contested recommendations with a statement of the rationales for the conflicting recommendations and offices where no recommendation for endorsement was made with a statement of the rationale for no endorsement. Each Regional PAC will present such a report to the statewide IFT PAC.

Individual locals may also submit documentation for their respective positions to the IFT statewide PAC. In determining endorsements for elections within their region, the Regional PAC shall review the voting records, questionnaire responses, and records of interviews with candidates. An incumbent with a seventy-five (75) percent or better voting record on IFT issues shall normally receive a Regional PAC recommendation for IFT endorsement.

In elections where there is no incumbent with a seventy-five (75) percent or better voting record on IFT positions, the Regional PAC should attempt to seek consensus on a recommendation. For a candidate to receive a recommendation for IFT support, the candidate's questionnaire and interview must demonstrate support for IFT positions.

If there is a division on a recommendation, the Regional PAC Chair shall invite local representatives to submit a statement of rationale for support or non-support of an IFT endorsement of any candidate not receiving consensus support in the Regional PAC. Under special circumstances, the Regional PAC may reach consensus and recommend an IFT endorsement for a candidate that is an exception to the above stated standard. In such an exception, the Regional PAC Chair or his/her designee shall submit a rationale for the recommendation to the IFT Executive Board.

For the purposes of this section, consensus means the concurrence of those in attendance at a regional meeting regarding a particular candidate or race. If there are one or more objectors on any question before the Regional PAC, the objectors shall reduce to writing the reasons for the objection, and that document shall be forwarded to the IFT PAC as part of the Regional PAC's report. Failure to do so prior to the IFT PAC endorsement meeting shall void the objection.

- Step 3. The IFT PAC Chair, with the assistance of the IFT Director of Political Activities, shall convene and conduct an IFT PAC endorsement meeting. Notice of this meeting shall be given at least thirty (30) days prior to the meeting date. The chair shall review the endorsement reports from the eighteen (18) Regional IFT PAC endorsement meetings. The committee shall:
  - (1) accept the endorsement recommendations of the Regional PACs for the state and federal offices open to election.
  - (2) make recommendations to the IFT Executive Board in cases where conflicts exist or where no recommendations were made.
  - (3) make endorsement recommendations to the Executive Board on statewide elections or statewide referenda issues.
  - (4) cause a final report stating the consensus endorsements and the conflicting endorsements with a statement of rationales for each candidate supported by an individual local or regional PAC to be prepared for the Executive Board.
- Step 4. The IFT Executive Board shall review the IFT PAC recommendations. Regional PAC decisions within the guidelines shall be honored by the Executive Board. If a Regional PAC makes a recommendation outside the guidelines, the Executive Board shall review and consider the statement of rationale. In accordance with the IFT Constitution and By-Laws, the Executive Board retains the final authority between IFT Conventions to make policy decisions regarding political endorsements.

#### (B) Legislative Activity

Committee members shall endeavor to establish favorable relationships with legislators and other political office holders within their districts and develop contacts with each Local President and/or COPE Chair within their district for lobbying purposes. The IFT will encourage all locals to establish an active COPE Committee with a COPE Chair who will work with the IFT PAC member in their district. The committee member shall encourage representation from each legislative district within their region at all IFT Lobby Day events.

#### **Section 4.** Meetings:

- (a) The IFT PAC shall meet as necessary, but at least:
  - (1) prior to primary elections for endorsements; and
  - (2) prior to general elections for endorsements.
- (b) The regional PACs shall meet as necessary, but at least:
  - (1) prior to primary elections for endorsements; and
  - (2) prior to general elections for endorsements.
- (c) Additional meetings may be called by the IFT Director of Political Activities for training purposes, prior to legislative sessions or for other reasons authorized by the President.
- (d) A Regional PAC Chair may cancel either of the meetings required by (b) (1) or (b) (2) if the chair considers the endorsement recommendations to be non-controversial and the President(s) of the local union(s) representing the mc1jority of the IFT members in the region concur. In order to cancel a meeting, the Regional PAC Chair must notify all Presidents of locals who have members who reside in the region. The notice must include:
  - (1) endorsement recommendations that are to be made even though no meeting will be held.
  - (2) a form to return to the IFT indicating concurrence with the meeting cancellation and endorsement recommendations.
  - (3) instructions for objecting in writing to the proposed cancellation and/or endorsement recommendations.

**Section 5.** The IFT will assist all IFT locals and the PAC by preparing endorsement guidelines, voting records of incumbent legislators, and candidate questionnaires. The IFT will also assist with regional meeting arrangements and provide IFT office space for such meetings where possible.

In Fall 2023, the IFT PreK-12 Constituency Council shared a survey with members asking two questions:

- 1. If you could change one thing about the working conditions of educators or school related staff, what would you change?
- 2. If you could change one thing about student learning conditions, what would you change?

Council members reviewed survey results to determine which concerns could be addressed with collective bargaining and/or legislation. In addition, council members reviewed responses and noted concerns that are currently being addressed by IFT staff as well as other constituency councils such as P-20, PSRPs, Next Generation and Special Education. The council noted that many of the trends are currently being addressed and an effort to streamline the work could benefit our organization to assure we are utilizing all resources to their fullest potential.

Council members recommended IFT field staff educate local and council presidents in using the AFT contract database as a reference to assist in collective bargaining for noted concerns. In addition, a recommendation was brought forward and approved by the IFT Executive Board to begin pursuing a common platform where local leaders can seek support and solutions for improving the working conditions and learning conditions of PreK -12 settings across the state. A platform will first be trialed by the executive board and then shared with local and council leaders. It is the intent of the council to establish communication opportunities that are both efficient and unifying.

Survey results were used on several occasions to inform discussions with legislators in addressing the severe educator shortage, supporting students with intensive behavioral needs and revisions to SB 100. More importantly, the survey results were used to focus the work of IFT in the advocacy for safe and culturally responsive learning environments. Our members consistently report increasing encounters with students needing intensive behavior support and lack of resources available to assure the safety of all persons across all school settings. Recommendations for addressing safety in the school environment were debated and captured in the resolution submitted by the council.

The PreK -12 Council recommends the following for legislative efforts:

- Changes to educator licensure that requires pre-service educators participate in comprehensive training for addressing students needing intensive social emotional and/or behavioral support
- State policies, programs and funding for wrap-around services

The PreK -12 Council recommends the following for local bargaining efforts:

- Annual de-escalation training for all school staff to include administration
- Full implementation of restorative practices for all school staff
- Individual safety plans and protocols for when students are in crisis
- Re-entry plans for students that have been excluded or removed from the classroom setting

The PreK - 12 Council recommends the following IFT training for locals:

• The Union's Response to Student Stress and Trauma, Part 1

#### **Public Employees Constituency Council Committee Activities (2022-2025)**

#### **Committee Meetings and Conferences**

The Public Employees Constituency Council Committee met at the IFT 2022 convention, the IFT Paraprofessional/Public Employees Conference on October 20, 2023, and the IFT President's Leadership Conference on March 15, 2024.

Our June 3, 2025, meeting focused on brainstorming ideas for resolutions for the IFT convention. We discussed staff shortages and artificial intelligence, sharing their impact on our councils. From these discussions, we created the Short Staffing and Filling of Vacancies resolution. Additionally, the committee contributed input to a resolution—created by IFT affiliates Local 1600 and Local 604—regarding AI Integration in Our Schools and Workplaces. As AI increasingly influences daily life, it is essential for unions to actively engage with and confront these emerging challenges.

#### **Professional Development and Member Engagement**

As members of the We Are One Illinois Coalition's Fix Tier 2 campaign, we contacted legislators and the Governor to support SB 1937 before the session ended.

On April 30, 2025, Deneen Taylor, IFT Field Service Director, facilitated a Zoom session titled "Putting the Union Puzzle Together: Understanding Various Aspects of Your Union, Its Benefits, and Ways to Make It Stronger." Members received valuable information about new member orientation, reviewed Weingarten Rights, and learned about COPE (Committee on Political Education) and PAC (Political Action Committee). The session was highly engaging, leaving members with a deeper understanding of the benefits the union provides.

#### **National Conference Participation**

From May 29–31, 2025, several committee members attended the AFT Public Employees Professional Issues Conference: "Uniting to Preserve Our Democracy" in Denver, Colorado. Participants joined workshops such as Organizing for Mass Mobilization, Protecting Our Workplaces, Mobilizing Our Power and Leadership, and Building Union Power. These sessions aimed to strengthen union membership engagement and mobilization in defense of democracy. During the conference, Matt Emigholz, President of IFPE Local 4408, served as a panelist for "Building Power and Developing Activists in the Current Climate," sharing insight into effective strategies for activism.

#### **Legislative Updates and Ongoing Initiatives**

At regular meetings, Dave Comerford from IFT Legislative reports on legislative issues affecting public employees. The General Assembly did not address Tier 2 in SB 1937 this session, and efforts will continue until the issue is resolved.

#### **Collaboration and Moving Forward**

During these challenging times, it is crucial to collaborate with affiliates, other unions, and community organizations to strengthen collective power and address issues facing public employees.

The IFT special education committee continues to play key roles in engaging and supporting IFT advocacy on behalf of all members, with a particular focus on critical special education issues in Illinois. Since the 2022 IFT convention, the committee has met to discuss and provide ideas and recommendations on issues important to Illinois educators and students. Committee members maintained a focus on protecting special educators' ability to provide services to students and ensure that all students have the quality educators, resources, and programs they deserve.

The committee maintains an interest in and monitors bills every legislative session related to special education in Illinois, hearing updates on bills related to special education at every meeting. In 2023, the committee provided feedback and raised concerns on the issues related to potential legislation that would have added requirements to districts and the Illinois State Board of Education (ISBE) regarding the use of universal screeners for students in grades K-2 for the risk factors of dyslexia. The committee also learned about Public Act 103-402, which mandated that Illinois produce a comprehensive literacy plan by January 31, 2024; provide resources for districts in evaluating and adopting literacy plans, including support for special populations such as students with disabilities, multilingual learners, and bidialectal students by July 1, 2024; offer literacy training opportunities for educators by July 1, 2025; and revise the grades 1-6 content test by July 1, 2026. This public act also mandated ISBE provide guidance on the use, administration and data interpretation of screening tools (dyslexia and other universal screeners) to identify students at risk of reading difficulties in grades K-2.

The committee keeps a particular focus on issues related to Illinois' administrative rule for special education, called Part 226. In the 2022-2023 school year, the committee affirmed IFT's longstanding advocacy for maintaining the statewide class size protections for students with disabilities found in Part 226.730. When in 2024, ISBE proposed changes to the administrative rules related to special educator qualifications in Section 226.850, the committee reviewed the changes and provided feedback on them.

In addition, the committee devoted several meetings to grappling with the challenges related to the state minimum requirements for special educator workload found in state administrative rules, Section 226.735. This workload requirement, which went into effect in 2009, requires unions and employers to develop a plan that sets workload limits for special educators. These workload limits must be based on an analysis of the activities for which the employer's special educators are responsible and must encompass, at minimum, individualized instruction; consultative services and other collaboration among staff members; attendance at IEP meetings and other staff conferences; and paperwork and reporting. During these conversations, committee members quickly identified significant weaknesses in Part 226.735. They shared workload plans, contract language, and organizing ideas related to setting limits on special educator workload. They determined that the current state workload requirement is meaningless in terms of supporting the work of special educators, resulting in untenable workload demands which limit the scope of practice of their day-to-day work with children who have IEPs. To support IFT in seeking potential legislative and policy changes to address these limitations, they examined the intersection of caseload and workload; studied caseload and workload limits from California, Ohio, and New York; considered recommendations from the California Teachers Association, the Ohio Federation of Teachers, and New York State United Teachers; and reviewed a workload analysis tool that Ohio developed from research at the University of Akron. One result of the committee's work on this issue was to submit a resolution for the 2025 IFT Convention to strengthen statewide protections for special educator caseload and workload.

In 2025, committee discussions also addressed the challenges associated with the streamlining of IEP forms. The committee acknowledged that the paperwork burden for IEPs has become increasingly onerous and growing, posing challenges for educators and families alike. The committee reflected on a stalled legislative effort, which had sought to mandate guidance from ISBE on this issue. Despite this setback, the committee recognized several opportunities to pursue alternative strategies, including partnering with other professional organizations to provide guidance and explore potential legislative solutions. The committee expressed interest in reaching out to other professional organizations to initiate collaborative conversations to address challenges associated with IEP form use, improve the experience for educators, and enhance family understanding of IEP documentation.

Other issues the committee shared ideas on include educator shortage challenges, paraprofessional retention strategies, and the need to ensure educators know special education laws and regulations. As a result of committee recommendations, IFT's Union Professional Issues Department distributes every fall a Know Your Rights guidance on special education class size and age range protections, deviation requests, and information on filing a state complaint for violations of special education law. The committee also provided input into developing IFT's updated vision statement.

The committee is also responsible for the Carl J. Megel Special Education Scholarship and votes each year to choose a recipient. The Megel Scholarship (\$20,000 total for 4 years) is awarded to an eligible student enrolled in a special education program. Each year the committee undertakes an intensive review of the application content, advertising procedures and timelines. In 2024 the committee devoted additional time updating the Megel Scholarship application to ensure the requirements and expectations are clearly stated for applicants and their families.

The IFT was pleased to award the Carl J. Megel Special Education Scholarship to the following high school students: 2023, Gavin Schumacher (Local 809); 2024, Oliver Fisher-Rohde (Local 1211); and 2025, Isabella Davis (Local 3939). These Megel scholarship recipients will use their award to pursue different post-secondary education opportunities. The Megel scholarship is a \$20,000 award (\$5,000 each year for four years).

The Union Leadership Institute (ULI) Committee has provided input to the development, implementation, and improvement of ULI courses. All ULI offerings returned to an in-person model from a hybrid model to promote more participation in the post COVID era. In addition, all courses include an anti-racist training/foundation and have been audited to make sure they align with the IFT's values. Establishing a selection process for new ULI instructors is necessary with the retirement of IFT staff members; building instructor capacity by shadowing, coteaching, and promoting diversity is essential to continue the high quality of course offerings.

#### Many courses were offered at ULI North:

- 44 members attended Boot Camp for Union Leaders, Effective Grievance Administration, and Introduction to Collective Bargaining in 2022-2023.
- In 2023, 39 members attended the inaugural accelerated schedule of courses including Boot Camp for Union Leaders, Communication Skills for Union Leaders (not yet an official ULI course), and Introduction to Collective Bargaining.
- For 2023-2024, 35 members attended the standard schedule offerings of Boot Camp for Union Leaders, Building and Sustaining Union Power, and Effective Grievance Administration.
- 37 participants attended the 2024 accelerated schedule offerings of Bootcamp for Union Leaders and Introduction to Collective Bargaining.
- For 2024-2025, 33 participants attended the standard schedule offerings of Effective Grievance Administration, Introduction to Collective Bargaining, and Strengthening the Paraeducator/Teacher Relationship (not yet an official ULI course).

#### The following courses were offered at Great Lakes ULI:

- In 2023, 79 participants (48 from Illinois) attended Effective Grievance Administration and Organizing, Introduction to Negotiations and Contract Campaigns, Powerful Partnerships: Organizing with Parents and Communities, and Union Leadership Skills to Build Strong Unions.
- In 2024, 86 participants (58 from Illinois) attended Effective Grievance Administration and Organizing, Introduction to Negotiations and Contract Campaigns, Powerful Partnerships: Organizing with Parents and Communities, and Union Leadership Skills to Build Strong Unions.

• In 2025, 87 people (66 from Illinois) registered for Effective Grievance Administration and Organizing, Introduction to Negotiations and Contract Campaigns, and Union Leadership Skills to Build Strong Unions.

Looking ahead, the traditional November, February, and April format will end. In its place, a new schedule for ULI North will begin in the fall of 2025. A fall ULI North will be held in September, October, and November; a spring ULI North will be held in February, March, and April. This new format will engage more members and staff. The ULI Committee will continue to provide valuable input into the best ways to maintain a vibrant, relevant, and effective ULI program that is rooted in antiracism.
